

ORDINANCE 389

AN ORDINANCE AMENDING ORDINANCE 379 CONCERNING THE RATES TO BE CHARGED FOR THE USE OF THE MUNICIPAL WATER SYSTEM INSIDE AND OUTSIDE THE CITY LIMITS OF MEXICO BEACH.

Whereas, the City of Mexico Beach has determined that it is in the best interest of the City that this ordinance be enacted; therefore, be it ordained by the City Council of Mexico Beach, Florida that the following changes be made to Ordinance 379:

**PART 1. USE OF THE MUNICIPAL WATER SYSTEM INSIDE THE CITY LIMITS**

**SECTION 7. CHARGE OR RATE FOR WATER SERVICE.**

**B. Residential Accounts:**

|               | <u>Rates</u>  | <u>Monthly Basis</u>                   |
|---------------|---------------|--|
| ¾ inch        | 4,000 gallons | \$20.30 excess \$1.57 per 1000 gallons |
| 1 inch        | 6,000 gallons | \$30.70 excess \$1.57 per 1000 gallons |
| Hydrant usage |               | \$1.57 per 1000 gallons                |

¾ inch – 4000 gallons irrigation meter \$20.30; excess at \$1.57 per 1000 gallons  
No sewer fees will be charged for an irrigation meter.

C. Duplex dwellings or multi-family (MDS) on the same building site serviced by one service connection, prior to the passage of this ordinance, shall pay the minimum charge of \$20.30 for the first unit and \$20.30 per each additional unit in the building. The base allowance, however, will be 4,000 gallons for each unit in the building. All excess usage will be charged at the rate of \$1.57 per 1000 gallons.

**D. Commercial Accounts**

|        | <u>Rates</u>   | <u>Monthly Basis</u>                    |
|--------|----------------|---|
| 1 inch | 6,000 gallons  | \$30.70 excess \$1.57 per 1000 gallons  |
| 2 inch | 12,000 gallons | \$57.30 excess \$1.57 per 1000 gallons  |
| 3 inch | 18,000 gallons | \$83.95 excess \$1.57 per 1000 gallons  |
| 4 inch | 24,000 gallons | \$111.93 excess \$1.57 per 1000 gallons |

E. Commercial buildings serviced by a ¾ inch meter prior to passage of this ordinance shall pay the minimum charge of \$30.70. All usage in this situation over 4,000 gallons will be charged at \$1.57 per 1000 gallons.

PART 2. USE OF THE MUNICIPAL WATER SYSTEM OUTSIDE THE CITY LIMITS

SECTION 5. CHARGE OR RATE FOR WATER SERVICE.

B. Residential Accounts:

|               | <u>Rates</u>  | <u>Monthly Basis</u>                   |
|---------------|---------------|--|
| ¾ inch        | 4,000 gallons | \$27.05 excess \$2.34 per 1000 gallons |
| 1 inch        | 6,000 gallons | \$44.00 excess \$2.34 per 1000 gallons |
| Hydrant usage |               | \$ 2.34 per 1000 gallons               |

C. Duplex dwellings or multi-family (MDS) on the same building site serviced by one service connection, prior to the passage of this ordinance, shall pay the minimum charge of \$27.05 for the first unit and \$27.05 per each additional unit in the building. The base allowance, however, will be 4,000 gallons for each unit in the building. All excess usage will be charged at the rate of \$2.34 per 1000 gallons.


D. Commercial Accounts


|        | <u>Rates</u>   | <u>Monthly Basis</u>                    |
|--------|----------------|---|
| 1 inch | 6,000 gallons  | \$44.00 excess \$2.34 per 1000 gallons  |
| 2 inch | 12,000 gallons | \$83.95 excess \$2.34 per 1000 gallons  |
| 3 inch | 18,000 gallons | \$120.25 excess \$2.34 per 1000 gallons |
| 4 inch | 24,000 gallons | \$160.33 excess \$2.34 per 1000 gallons |


SECTION 6. EFFECTIVE DATE. This ordinance shall become effective as provided by law.
