

ORDINANCE NO. 439

AN ORDINANCE AMENDING ORDINANCE NO. 419 THE SAME RELATING TO THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR 2002-2003, THE CITY OF MEXICO BEACH SANITATION DEPARTMENT, BY INCREASING CERTAIN ITEMS, DECREASING CERTAIN ITEMS, ADDING CERTAIN NEW ITEMS, PROVIDING AN EFFECTIVE DATE.

Section 3. This Ordinance No. 439 shall become effective 4/18/03 according to law.


