

ORDINANCE NO. 465

AN ORDINANCE AMENDING ORDINANCE NO. 455, THE SAME RELATING TO THE APPROPRIATION OF FUNDS FOR THE FISCAL YEAR 2003/04 FOR THE CITY OF MEXICO BEACH WATER DEPARTMENT, BY INCREASING CERTAIN ITEMS, DECREASING CERTAIN ITEMS, ADDING CERTAIN NEW ITEMS, PROVIDING AN EFFECTIVE DATE.

Section 3. This Ordinance No. 465 shall become effective December 9, 2003 according to law.

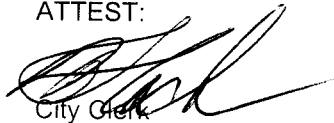
