ORDINANCE NO. 73

AN ORDINANCE RELATING TO THE APPROPRIATION OF FUNDS FOR FISCAL YEAR 1977-1978 FOR THE TOWN OF MEXICO BEACH, FLORIDA, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE ORDINARY AND REGULAR REQUIREMENTS OF THE TOWN OF MEXICO BEACH, FLORIDA, FOR FISCAL YEAR 1977-1978 AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Town Council is of the opinion that it is necessary for the immediate protection and preservation of the peace, safety, health, and property of the Town and its inhabitants that this ordinance shall take effect October 1, 1977, therefore

BE IT ORDAINED BY THE PEOPLE OF THE TOWN OF MEXICO BEACH, FLORIDA:

Section 1. There is hereby appropriated the sum of \$216,757 for the General Fund for the Fiscal Year 1977-1978 to be used in the operation of said departments for the Town of Mexico Beach, Florida, as set forth in the Budget of said Town on file with the Town Clerk.

There is hereby set aside 3 mills or approximately \$25,000 ad valorem tax which is a part of this General Fund Budget, to be withdrawn and placed into a separate banking account to be applied only to Sewer and Water facilities as directed by the Council.

Section 2. The Town Clerk is hereby authorized and directed to publish a notice of this ordinance as provided by law.

Section 3. This ordinance shall take effect October 1, 1977.
