

ORDINANCE NO 741

AN ORDINANCE ADOPTING A PLANNED UNIT DEVELOPMENT OVERLAY DISTRICT (PUD) FOR THE PARCELS OF LAND LYING WITHIN THE CITY OF MEXICO BEACH, FLORIDA, CONTAINING APPROXIMATELY 554 ACRES; LOCATED ALONG THE WEST SIDE OF THE CITY ON BOTH THE NORTH AND SOUTH SIDE OF HIGHWAY 98, INCLUDING PARCEL ID NUMBERS 04101-010-000, 04101-030-000, 04101-031-000, 04101-040-000, 04101-050-000, 04101-060-000, AND 04102-010-000, AND ALL AS MORE PARTICULARLY DESCRIBED IN THE BODY OF THE ORDINANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT; AND PROVIDING AN IMMEDIATELY EFFECTIVE DATE.

WHEREAS, The St. Joe Company, the owner of real property designated herein, has initiated this ordinance by filing a petition praying that said real property, being more particularly described below be made subject to the Planned Unit Development (“PUD”) Development Plan, hereinafter referred to as PUD Master Plan and attached and incorporated as Exhibit “B,” as an overlay district and otherwise conform to the requirement of the underlying Tourist Mixed Use zoning district and Preservation zoning district, as applicable; and

WHEREAS, this ordinance does not modify, waive, or reduce any requirement of the City of Mexico Beach Comprehensive Plan; and

WHEREAS, this ordinance adopts the overlay district only for the real property described herein; and

WHEREAS, the Mexico Beach Planning & Zoning Board reviewed the PUD request, conducted a public hearing on February 3, 2020 and on February 10, 2020, and recommended approval of the request with the stipulations to address (i) the traffic of the single entry for the boat ramp and apartments, (ii) parking at the apartments and beach parking, (iii) beach access for the people on the north side of the development including some access for people to drive and park at

the beach, (iv) additional room for parking at the boat and potentially ownership of the boat ramp by Mexico Beach, and (v) to address canal traffic from the anticipated additional boats; and

WHEREAS, the City Council conducted a first reading of this ordinance on February 11, 2020 and a second reading and public hearing on February 25, 2020; and

WHEREAS, after consideration of the evidence presented at the hearing, adduced in a properly advertised public hearing conducted on February 25, 2020, the City found the requested PUD Master Plan to be consistent with the currently applicable Mexico Beach Comprehensive Plan and to reasonably accomplish a legitimate public purpose.

NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF MEXICO BEACH, FLORIDA:

SECTION 1. The following described parcel of real property situated within the municipal limits of the City of Mexico Beach, Florida, is made subject to the Town Village Planned Unit Development Master Plan,

SEE ATTACHED AND INCORPORATED EXHIBIT "A" (the "Property") and the City's Zoning Map is amended accordingly to show an overlay district.

SECTION 2. The requirements set forth by the Town Village Planned Unit Development Master Plan, attached and incorporated as Exhibit "B," apply to the Property as an overlay district and control in the event of a conflict with the Land Development Code. Except as noted by Exhibit B, the underlying zoning district requirements shall apply. Neither this ordinance nor the PUD Master Plan modify or waive any requirement of the Mexico Beach Comprehensive Plan.


SECTION 3. Development within the PUD is subject to all applicable development permits (i.e. environmental review, building permits, subdivision plats, etc.). As required by the Land Development Code, the land described by Exhibit A must have an active building permit

within three years of the effective date of this ordinance or the PUD Master Plan approval is withdrawn automatically, and the underlying zoning district standards apply.

SECTION 4. All ordinances or parts of ordinances in conflict herewith are repealed to the extent of such conflict.


SECTION 5. This ordinance shall take effect immediately upon passage.

BEGIN AT THE SOUTHEAST CORNER OF SECTION 15, TOWNSHIP 6 SOUTH, RANGE 12 WEST, BAY COUNTY, FLORIDA AND PROCEED NORTH 89 DEGREES 56 MINUTES 33 SECONDS WEST, ALONG THE SOUTH BOUNDARY LINE OF SAID SECTION 15, FOR A DISTANCE OF 1,718.61 FEET TO THE INTERSECTION OF SAID SOUTH BOUNDARY WITH THE NORTHERLY RIGHT OF WAY LINE OF U.S. HIGHWAY 98 (100' RIGHT OF WAY); THENCE LEAVING SAID SOUTH BOUNDARY LINE PROCEED NORTH 56 DEGREES 2 MINUTES 22 SECONDS WEST, ALONG SAID NORTHERLY RIGHT OF WAY LINE, FOR A DISTANCE OF 5,200.92 FEET; THENCE LEAVING SAID NORTHERLY RIGHT OF WAY LINE PROCEED NORTH 22 DEGREES 46 MINUTES 49 SECONDS EAST, FOR A DISTANCE OF 533.32 FEET TO A POINT ON A CURVE CONCAVE NORTHERLY, HAVING A RADIUS OF 7,406.99 FEET, THROUGH A CENTRAL ANGLE OF 14 DEGREES 21 MINUTES 34 SECONDS; THENCE PROCEED EASTERLY ALONG SAID CURVE FOR AN ARC DISTANCE OF 1,856.35 FEET, (CHORD BEARING AND DISTANCE = SOUTH 82 DEGREES 27 MINUTES 44 SECONDS EAST, FOR A DISTANCE OF 1,851.50 FEET); THENCE SOUTH 89 DEGREES 38 MINUTES 32 SECONDS EAST, FOR A DISTANCE OF 3,804.84 FEET TO A POINT ON THE EAST BOUNDARY LINE OF AFORESAID SECTION 15; THENCE SOUTH 3 DEGREES 23 MINUTES 29 SECONDS EAST, ALONG SAID EAST BOUNDARY LINE, FOR A DISTANCE OF 3,137.64 FEET TO THE POINT OF BEGINNING.
