

Check List for Beach Vendor Class I Permit Application

The application applies to vendors having a business location actually operating on the beach. Each packet must include the following items (please check off each item so that you know you have fulfilled the requirements.)

- A signed copy of the Beach Vendor Permit Process and Application cover page.
- A completed application, on forms provided—completely filled out and notarized.
- Letter from the upland property owner giving permission of the business to operate.
- Copies of each driver's license for all persons who work in the business.
- State sales tax number and Federal Employment Identification Number (FEIN).
- Original certificate of current general liability insurance, showing the City of Mexico Beach as additional insureds, in the minimum amount of \$1,000,000 per occurrence and \$3,000,000 in the aggregate.
- The following documentation is required to be provided to the City of Mexico Beach for vehicles and titled equipment used in the business:
 - Copy of Certificate of Title.
 - Copy of Florida Registration.
 - Copy of current vehicle liability insurance certificate.
- Application Fee of \$100.00
- City of Mexico Beach Occupational License

Class I Beach Vendor Permit Process and Application

A Class I Permit is for a business actually operating from the beach itself. All Beach Vending Permits issued by the City expire at the end of the calendar year in which they are granted.

The City mandates that all businesses operating within city limits obtain an Occupational Permit. Additionally, any business conducting operations, whether partially or entirely, on the beach must secure a Beach Vendor Permit.

Location

Beach Vending Permits only apply to the location and activities specified in the application. Additional locations require a new application for additional Beach Vending Permits. Only one Class I Beach Vending permit shall be issued to each qualifying upland parcel.

On-Beach Vending

If the vendor intends to sell at one of the four reserved locations, the vendor must apply for a Class I Beach.
